

## **Milford's "Rainy day - win an umbrella for you and a friend" Social Promotion Terms and Conditions**

These Terms and Conditions govern the Milford "**Rainy day - win an umbrella for you and a friend**" Social promotion. By entering, you accept these Terms and Conditions.

**1. Promoter:** Milford Asset Management Limited is the promoter (**Promoter**).

**2. Entry Period:** 8am on 17th July 2025 – 8pm on 27th July 2025

**3. Eligibility:** Only New Zealand residents who are living in New Zealand for the duration of the promotion can enter. If you are under the age of 18, you must get approval from your parent/guardian before you enter and if you are under 18 on the date the Prize is awarded, it will be awarded to your parent or guardian. By approving your participation or accepting any Prize on your behalf, your parent or guardian accepts these Terms and Conditions. Staff and other personnel (and their immediate family members) of the Promoter are not eligible to enter the promotion and their entries will be disqualified.

**4. Entry instructions:** To enter,

**Instagram and Facebook only:** you must, during the Entry Period, follow the Promoter's Instagram and/or Facebook account and tag a friend in the comments section – by completing both actions together, you will have successfully entered the draw.

**5. Number of winners:** There will be Four (4) Prize winners. 2 winners on Facebook and 2 winners on Instagram.

**6. Winner determination:** The winners will be determined by a random draw. The first four valid entries drawn (two from entries via Instagram and two from entries via Facebook) from the entries received during the Entry Period will win the Prize. The winners will be determined by a draw to be held after 8pm on 27th July 2025. The Promoter's decision regarding the winners of the Prize will be final and binding.

**7. Prize:** The prize will be a Blunt Umbrella Metro (**Prize**) with a total recommended retail price of approximately NZ\$129. There will be four Prizes available, one for each of the four Prize winners.

**8. Entry limits:** You can only enter once on each social media platform.

**9. Winner notification:** The winner will be notified by a private message on the social media channel they used to enter the promotion within ten (10) business days of determination.

**10. Unclaimed Prizes:** If a winner is not reasonably able to be contacted, and/or has otherwise not accepted or claimed the Prize, within twenty (20) days of the winner being determined, the Prize may be forfeited and another winner will be drawn by the Promoter based on the same criteria.

### **Collection and use of personal information:**

**11.** The Promoter collects personal information about you in order to conduct and manage the promotion, including to award any Prizes. If you do not provide the required personal information, you may not be able to participate.

The Promoter may, at any time, require you to produce documentation to establish to the Promoter's satisfaction the validity of your entry.
