In February the Fund generated a return of 0.34%, in line with its objective to deliver a return in excess of the Reserve Bank of New Zealand (RBNZ) Official Cash Rate (OCR) after fees.

The RBNZ Monetary Policy Statement in February saw the OCR increased by 0.5 percentage points to 4.75%. Short-dated NZ dollar bank bills, a reflection of interbank funding levels, continued their climb higher throughout the month, driven by market expectations of further OCR increases in the near term.

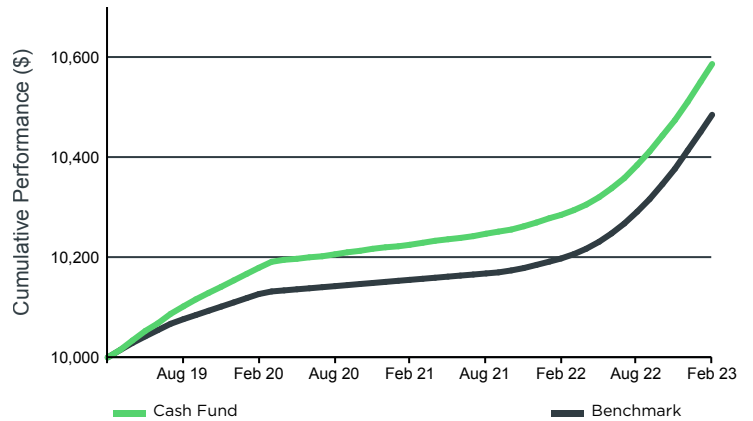
Looking forward, this should continue to benefit the Fund by increasing the interest rates into which it can progressively reinvest maturing holdings. Our base case remains for higher interest rates from here, albeit elevated market expectations seem higher than what may be realised if inflation moderates and/or growth slows.

The portfolio management of the Fund remains focused on maintaining its low-risk strategy which is built on a diversified portfolio of cash, short-dated debt securities and term deposits, so as to protect capital.
