In July the Fund generated a return of 0.5%, which was in line with its objective to deliver a return in excess of the Reserve Bank of New Zealand (RBNZ) Official Cash Rate (OCR) after fees.

Short-dated NZ dollar bank bills, a reflection of interbank funding levels, moved lower throughout the month. This was driven by the market increasing its expectation of the quantum and pace of OCR cuts before year end, following the RBNZ's July Monetary Policy Review and a lower second quarter inflation reading. Our expectation is that when compared to recent years, interest rates will remain at relatively elevated levels for some time.

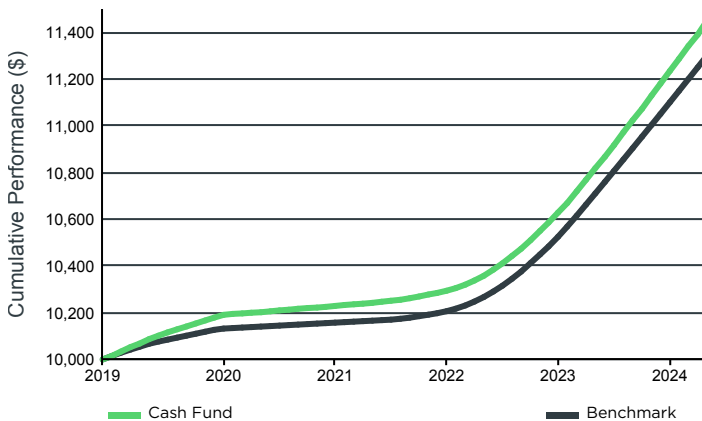
This will continue to benefit the Fund in terms of the interest rates into which the Fund can reinvest maturing holdings. The portfolio management of the Fund remains focused on maintaining its low risk strategy, which is built on a diversified portfolio of cash, short-dated debt securities and term deposits, so as to protect capital. As a reminder, while the yield of the Fund may vary over time, its objective is to deliver a return in excess of the OCR after fees. We continue to aim to deliver on this objective.
