In March the Fund generated a return of 0.3%, in line with its objective to deliver a return in excess of the Reserve Bank of New Zealand (RBNZ) Official Cash Rate (OCR) after fees.

Short dated NZ Dollar bank bills, a reflection of interbank funding levels, continued to move lower throughout the month. This was driven by the upcoming April RBNZ meeting where a further cut to the OCR is expected. Whilst the RBNZ has guided for further OCR cuts to come, our expectation remains that when compared to recent years, interest rates will remain at relatively elevated levels for some time.

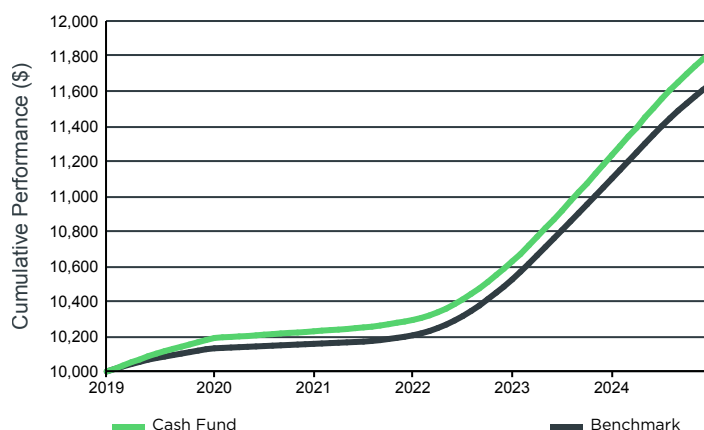
The portfolio management of the Fund remains focused on maintaining its low-risk strategy, which is built on a diversified portfolio of cash, short-dated debt securities and term deposits, to protect capital. As a reminder, while the yield of the Cash Fund may vary over time, its objective is to deliver a return in excess of the OCR after fees.
