The Fund returned 2.4% in November, bringing the one-year return to 4.6%. November was a very strong month for returns, an encouraging development after a tough year for asset prices. The month saw large rallies in both bond and share markets with a rising tide lifting all boats. In a remarkably swift change in direction from the weaker markets over the three months prior, investors have rapidly embraced the notion of a soft landing, and stocks and bonds have moved to reflect this consensus.

For the Fund, the strong performance of bonds has been the key driver of returns. In November, the outperformance of corporate bonds relative to government bonds was a strong tailwind, as the portfolio is heavily tilted to corporate bonds. On the stock side, falling bond yields helped performance of the interest rate sensitive names that we hold, such as Australian property group Stockland (+16.7%).

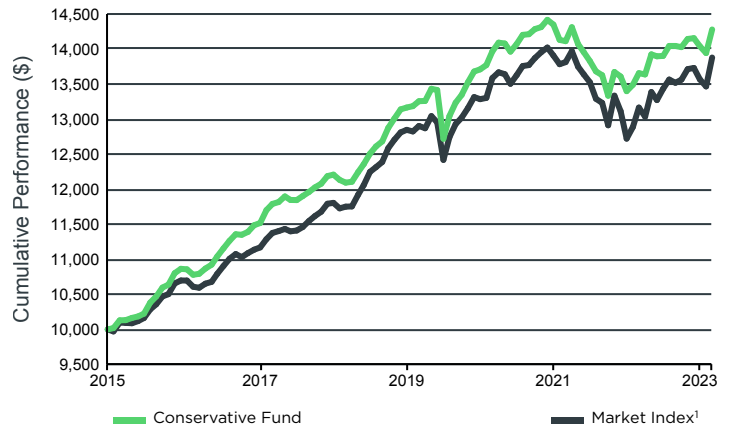
Looking ahead, we are encouraged that the cycle is evolving in a benign way, with inflation falling and economic growth remaining modestly positive. But we are concerned that investors have become a little enamoured with the soft-landing outlook and much of the good news is already priced in. To that end, the Fund reduced exposure to both stocks and bonds at the end of the month.

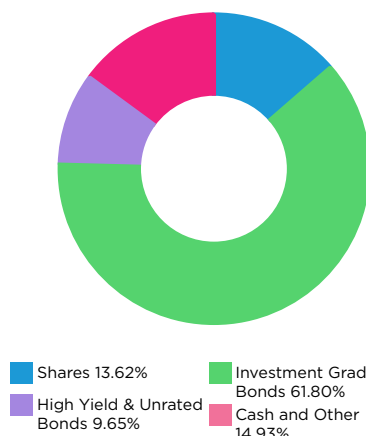

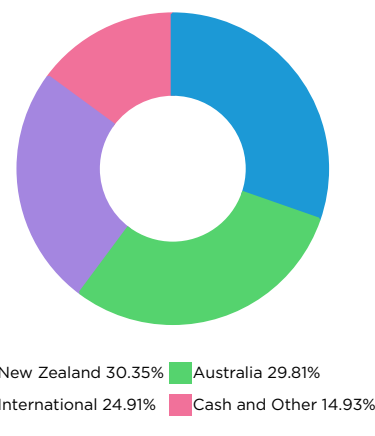
