The Fund returned 0.7% in October, with New Zealand shares (+1.7%) outperforming global shares in local currency (-0.9%) and Australian shares (-1.3%). Returns for unhedged global shares (+4.8%) were strong following the fall in the New Zealand dollar.

Global share markets were under pressure over the month, as US yields increased 0.5% on expectations of a Trump win, and broadly stronger US economic data. While results are unknown at the time of writing, a Trump win could entail extensions of US tax cuts and large-scale tariffs, with the former increasing the fiscal deficit and the latter potentially keeping inflation above target for longer. Both of these factors are likely to keep interest rates higher, which is negative for fixed income investments.

The Fund has had a meaningful New Zealand dollar short position against the US dollar for several months, which paid off over October, as the currency depreciated 5.9%, benefiting Fund performance. We continue to think the NZ dollar is vulnerable to further downside, given rate cuts are reducing the interest rate differential that investors previously received from owning the NZ dollar. Top company performers were US bank JP Morgan (+5.9%), UK bank NatWest (+6.9%) and streaming service Netflix (+6.6%). Both the banks performed well on the back of higher rates which helps interest income, while Netflix delivered a third quarter result that was broadly better than feared.

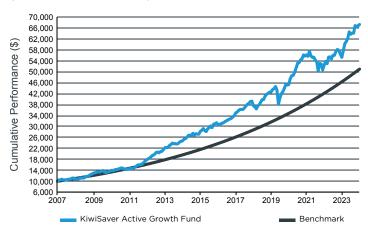
Looking forward, November has a number of potentially major events for markets including the US election, several monetary policy meetings and company earnings reports. Shares remain supported by strong growth in the US and the prospect of further interest rate cuts. Headwinds for shares are relatively high valuations, slower economic growth outside the US, and the risk that interest rate cuts do not eventuate as expected. On balance, the strategy of the Fund is to be active and take market opportunities as they arise.

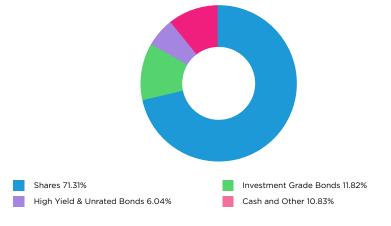
