March Quarter 2022

Challenging market conditions over the first quarter push returns for Multisector KiwiSaver funds down. KiwiSaver assets fall, ending the quarter on NZ\$86.9 billion.

Morningstar's quarterly KiwiSaver Survey is designed to help New Zealand investors assess the past performance and other key characteristics of their KiwiSaver superannuation options. The accompanying tables show KiwiSaver fund returns for the three months, one, three, five and ten years to 31 March 2022.

Market Commentary

COVID-19 related headlines took a back seat over the quarter as Russia's invasion of Ukraine in late February caused a global shock. The shock reverberated through into markets, with equities declining and bond yields rising. Commodity prices soared given Russia is a key producer of several important commodities including oil, gas, and wheat. World shares had already been weak even before the invasion of Ukraine, and the news of Russia's attack sent them lower again in late February and early March, shares then staged something of a recovery, probably because investors felt they were getting a clearer handle on both the likely geopolitical endgame and the likely evolution of monetary policy. Despite the recovery, however, shares were still down for the quarter, with the MSCI World Index down 6.6%.

New Zealand equities were weak over the March quarter, with the index down 7.1%. Among the large caps, there were large setbacks for Fisher & Paykel Healthcare and Ryman Healthcare, with only a few names such as Meridian Energy and telco Spark showing any significant gains. The Australian market has been a rare example of a developed economy share market that is ahead for the quarter. The S&P / ASX 200 Index has delivered a gain of 3.9%. Unsurprisingly, the star of the show in a world of strongly higher commodity prices has been the resources sector, and the S&P / ASX 300 Index of metals and mining up 16.8%; the utilities have also performed well, with a 16.6% gain. The financials sector has also made a positive contribution, with the financials ex the A-REITs up 3.1%. Some sectors, however, have struggled, notably consumer discretionary (down 12.2%), IT (down 11.3%) and healthcare (down 10.6%).

New Zealand REITs performed very much in line with the wider New Zealand share market, and the S&P / NZX All Real Estate Index has delivered a loss of 6.2%. The A-REITs, on the other hand, substantially underperformed the wider Australia market, with a loss of 5.6%. Cash rates have risen further as the Reserve Bank of New Zealand, continued to tighten monetary policy from the stimulatory settings it had set through the COVID-19

outbreak. As at March the 90-day bank bill yield was up 0.7% since the start of the year. Bond yields have also risen over the period, with the 10-year government-bond yield up 0.9%. International fixed interest continued to struggle, the Bloomberg Global Aggregate lost 7.8% in U.S. dollars. Relatively low-yielding subsectors within the asset class have provided little protection, with Global High Yield (low credit quality) down by 6.6% and emerging-markets debt down by 9.9%.

Fund Manager Results

KiwiSaver funds generally reflected the challenging underlying market conditions experienced over the March quarter with the bulk of multisector funds experiencing a return of less than negative 3.0%.

The average multisector category returns ranged from negative 3.9% for the Conservative category to negative 6.5% for the Aggressive category. Top performers over the quarter against their peer group includes **BNZ First Home Buyer** negative 2.1% (Multisector Conservative), **Superlife Conservative** negative 2.9% (Multisector Moderate), **AMP Income Generator** negative 1.1% (Multisector Balanced), **Aon Milford** negative 3.7% (Multisector Growth), and **Superlife High Growth** negative 4.8% (Multisector Aggressive).

It is most appropriate to evaluate performance of a KiwiSaver scheme by studying its long-term returns. Over 10 years, the Aggressive category average has given investors an annualised return of 10.1%, followed by Growth (9.9%), Balanced (8.0%), Moderate (5.8%), and Conservative (5.1%).

Market Share

KiwiSaver assets on the Morningstar database fell during the March quarter to be NZ\$86.9 billion as at 31 March 2022. ANZ leads the market share with more than NZ\$18.5 billion. ASB is in second position, with a market share of 16.1%. Westpac holds third spot ahead of Fisher Funds, while Kiwi Wealth sits in fifth spot. The six largest KiwiSaver providers account for approximately 70% of assets on our database.

About This Survey

This survey groups KiwiSaver options according to their mix of income and growth assets, or “asset allocation”. This is one of the most important decisions to make when saving for retirement. The term “income assets” refers to cash and fixed interest securities that generally produce stable and reliable returns but offer little opportunity for long-term capital growth. Returns from “growth assets” such as property and shares will be erratic – as recent market volatility has demonstrated – but over time have shown greater capacity for increasing in value. The mixture of income and growth assets is the major determinant of potential return and volatility.

Investors may notice differences between the returns published in this survey and those they see elsewhere. There are several possible reasons for this. First, the returns published here are after fees but before tax. Second, we take the associated tax credit into consideration when calculating and publishing these returns, while some fund managers base their published performance figures on month-end unit prices only. ■■

We have chosen a conservative KiwiSaver balance, of \$10k, and applied the JUNO fee for that balance (\$60) to get 0.60%.
